## **COLLEGE RULES AND REGULATIONS**

### **CODE OF CONDUCT**

7. Be honest and apologize for any mistake you have committed.

### **DISCIPLINE: NORMS AND REGULATIONS**

“The path of duty is the way to glory”. Discipline an integral part of education, is of prime importance in the college. With view to building an ideal academic atmosphere in the college premises, students are requested to strictly adhere to the rules and regulations given below:

1. They should not use cell phones in the college campus.
2. They should wear clean and tide uniform on all working days.
3. Students should wish the teachers when they meet them for the first time of the day.
4. They should be punctual and regular in attending the classes.
5. Students should always carry their ID cards issued by the college while they are in the campus.
6. Indifference to studies, non-submission of practical records and assignments in time, avoidance of tests and examinations conducted by the college, discourtesy to establishment are strictly discouraged.
7. Coming to college in an intoxicated state, smoking within the college campus, using obscene and vulgar words against others, disrespect to teachers, indulging in malpractice during examinations and moral delinquency are serious offences.
8. Students are warned-NOT TO INVOLVE IN RAGGING. Ragging is a very serious offence.

## **REGULATIONS REGARDING ATTENDANCE**

### **1. The class-hours are as follows:**

**Fore-noon Session : 9.00 a.m. to 1.00 p.m.**

**After-noon Session: 2.00 p.m. to 5.00 p.m.**

### **DRESS CODE**

**Male students are permitted to wear pants and shirts only. The shirt should be neatly tucked in. Wearing of jeans and T-shirts is prohibited.**

**Girl students are permitted to wear only salwar kameez with dupatta or South Indian attire. They should not wear miniskirts or pants.**

**Students are permitted to wear only shoes.**

**Male students are to have their hair neatly cut and combed.**

### **IDENTITY CARD**

**All students are expected to wear the identity cards provided at all times.**

### **PUNCTUALITY AND ATTENDANCE**

**All students are expected to be punctual and attend all classes. Late attendance and absence in one of the classes will be treated as absent for half a day.**

**Every student should have a minimum of 85% attendance to be eligible to take the University Examination. Parent/Guardians of students whose attendance is low will be intimated. It will be the duty of the parent/guardian to ensure that their wards attend classes regularly and avoid recurrence of low attendance by them.**

### **CLASS WORK AND TESTS**

**It is mandatory for all students to appear for the model examinations prior to appearing to the University Examinations. Students failing to secure minimum qualifying marks in these examinations will not be allowed to take the University Examination.**

**Students will also have to complete assignments, tutorials and attend classes and cycle tests that will be conducted in the respective subjects from time to time. All students are required to get a minimum of 50% marks in these tests.**

**Parents/guardians are advised to periodically meet the class in-charge / HoD / to know about the progress of their wards.**

**If found violating these instructions, the students will be solely responsible for the consequences. Ignorance of these rules and regulations will not be accepted as an excuse for any non-compliance.**

### **THE MENTOR-MENTEE COUNSILING SYSTEM**

Each student will be assigned as a ward to a member of the faculty counselor. Students must meet their respective counselors outside regular class hours for personal advice and guidance. Attendance particulars or any other certificates shall be routed to the principal through the counselor and Head of the Departments. Counselors will closely monitor the progress of students in studies, regularity in attendance and behavior in and out of the campus. The students should update the counseling records at the time of every meeting. The principal will take appropriate action, if any adverse remarks are received from the counselors against their wards and informed to parents if necessary.

### **RAGGING**

- 1. The Act No. 7 of 1997 of the Tamil Nadu Legislative Assembly, published on 14<sup>th</sup> February 1997 prohibits ragging in Educational Institutions in the state of Tamil Nadu.**
- 2. The Act expresses “ragging means display of noisy, disorderly conduct, doing any act, which causes or is likely to cause physical or psychological harm, raise apprehension, fear, shame, or embarrassment to a new student, in any educational institution”.**
- 3. Ragging is strictly prohibited in and out of the educational institution. Whoever directly or indirectly involves, participates in, abets or propagates “Ragging” shall be punished with imprisonment for a term which may extend up to 2 years and shall be liable to pay fine which may extend to Rupees Ten Thousand.**

4. Any student committing such an offence shall also be dismissed from the educational institution and such a student cannot be admitted in any other educational institutions.
5. Whenever any student complaints of ragging, immediately inquiry will be made and if found true, the student concerned will be expelled.
6. Principal is the final authority in all-disciplinary matters.

### **LIBRARY RULES AND REGULATIONS**

1. The faculty and students of the college are expected to make the best use of the library, subject to the following rules.
2. The library will remain open from 09.00 am to 05.00 pm on all working days.
3. Perfect silence should be maintained in the library.
4. A student is eligible to take 2 Library books at a time and books will be issued during the library period of respective classes against their ID Card.
5. Students can keep the books for one week (7 days) at a time.
6. The books should be returned on or before the due date, which is marked on the first page of the book issued.
7. Reference Books, Magazines, Journals, and dailies should not be taken out from the library.
8. Students or staff, who leave the college for any reason in the middle of the term should return the books before they leave the college and obtain a no due certificate from the library.
9. Writing or underlining in a book or tampering the book in any manner is strictly prohibited or otherwise the students should replace new book.
10. The library will be closed on Sundays, public holidays and during the vacation period.

## **HOSTEL RULES AND REGULATIONS**

1. All students must respect, obey and follow the rules and regulations Implemented in the hostel.
2. The students should clean their room/ hostel premises neat and clean.
3. Hostellers are required to be within the hostel premises by 6.00 P.M. and attendance Will be taken by the warden in addition the student must do punching after 6 PM.
4. Entry into the hostel between 8.00 P. M. and 6.A.M. is strictly prohibited.
5. Hostel mess is compulsory for all the hostellers. The hostel mess is open between 06.30 A.M. to 09.00 A.M. for breakfast, 12.30 P.M. to 02.30.P.M. lunch and 07.00 P.M. to 09.00 P.M. for dinner.
6. Strict silence should be observed between 10.00 P.M. to 06.00 A.M. in the hostel.
7. Hostellers should not entertain non hosteller's entry into their room and should share food to the non-hostellers.
8. Weekend outings are allowed on Sundays, the student should take permission from Warden. The outings must be entered in a register in the security gate. The student should sign in the outgoing register after you return to the hostel.
9. First year students are not allowed for outing during weekends without the parents or local guardians.
10. In case of vacation leave/personal leave/sick leave the students should submit Permission, letter should be obtained from the head of the institution or from the authorized in charge of the institution and submit the same to the warden and get the leave permission out pass before leaving from the hostel premises.
11. Use of cell phones after 10.00 P.M. is not allowed.
12. Use of drugs, alcohol and intoxicants of any kind is strictly prohibited.
13. Hostellers are not allowed to stay in the hostel room during the class hours without valid reasons, the student must inform her absence to the warden.
14. Ragging in any form (making unpleasant noise, disorder conduct, doing any act which causes or likely to causes physical or psychological harm or raise apprehension or peak of shame or an embarrassment to the new student. which include teasing abusing playing practical jokes on or causing hurt to such students or asking the new student to be any act or to perform such things which such student will not in the ordinary course willingly do is strictly for bidden. If found guilty she will be expelled and also liable for prosecution under the Tamil Nadu prohibition of ragging act 1997.

## **EXAMINATION RULES AND REGULATIONS**

### **ATTENDANCE REQUIRED FOR ADMISSION TO EXAMINATIONS**

- 1. No candidate shall be permitted to appear the University examination unless he/she has attended the course in the subject for the prescribed period in an affiliated Institution recognized by the University.**
- 2. Each academic year shall consist of not less than 270 days (inclusive of the University exam days).**
- 3. A candidate is required to have a minimum of 85% attendance in both theory and practical separately in each subject before admission to the examination for all the years to study in the B. Pharm Degree Course.**
- 4. A candidate lacking in the prescribed attendance and progress in anyone subject in theory and practical shall not be permitted for admission to the entire examination in the first appearance.**

### **MODE OF EXAMINATIONS**

**The End Semester Examinations for each theory and practical course through semesters I to VIII shall be conducted by the university except for the subjects that are non-university examinations shall be conducted by the subject experts at college level and the marks/grades shall be submitted to the university.**

#### **The Semester grade point average (SGPA)**

**The performance of a student in a semester is indicated by a number called Semester Grade Point Average' (SGPA). The SGPA is the weighted average of the grade points obtained in all the courses by the student during the semester. For example, if a student takes five courses (Theory/Practical) in a semester with credits C1, C2, C3, C4 and C5 and the student's grade points in these courses are G1, G2, G3, G4 and G5, respectively, and then students' SGPA is equal to:**

$$\text{SGPA} = \frac{C_1G_1 + C_2G_2 + C_3G_3 + C_4G_4 + C_5G_5}{C_1 + C_2 + C_3 + C_4 + C_5}$$

The SGPA is calculated to two decimal points. It should be noted that, the SGPA for any semester shall take into consideration the F and ABS grade awarded in that semester. For example, if a learner has a F or ABS grade in course 4, the SGPA shall then be computed as:

$$\text{SGPA} = \frac{C_1G_1 + C_2G_2 + C_3G_3 + C_4 * \text{ZERO} + C_5G_5}{C_1 + C_2 + C_3 + C_4 + C_5}$$

### Cumulative Grade Point Average (CGPA)

The CGPA is calculated with the SGPA of all the VIII semesters to two decimal points and is indicated in final grade report card/final transcript showing the grades of all VIII semesters and their courses. The CGPA shall reflect the failed status in case of F grade(s), till the course(s) is/are passed. When the course(s) is/are passed by obtaining a pass grade on subsequent examination(s) the CGPA shall only reflect the new grade and not the fail grades earned earlier. The CGPA is calculated as:

$$\text{CGPA} = \frac{C_1S_1 + C_2S_2 + C_3S_3 + C_4S_4 + C_5S_5 + C_6S_6 + C_7S_7 + C_8S_8}{C_1 + C_2 + C_3 + C_4 + C_5 + C_6 + C_7 + C_8}$$

where  $C_1, C_2, C_3, \dots$  is the total number of credits for semester I, II, III, ..., and  $S_1, S_2, S_3, \dots$  is the SGPA of semester I, II, III, ..., .

### Declaration of class

The class shall be awarded on the basis of CGPA as follows:

First Class with Distinction = CGPA of 7.50 and above

First Class = CGPA of 6.00 to 7.49

Second Class = CGPA of 5.00 to 5.99

### PROJECT WORK

All the students shall undertake a project under the supervision of a teacher and submit a report. The area of the project shall directly relate any one of the elective subjects opted by the student in semester VIII. The project shall be carried out in group not exceeding 5 in number. The project report shall be submitted in triplicate (typed & bound copy not less than 25 pages).

The internal and external examiner appointed by the University shall evaluate the project at the time of the Practical examinations of other semester(s). Students shall be evaluated in groups for four hours (i.e., about half an hour for a group of five students). The projects shall be evaluated as per the criteria given below.

**PRACTICE SCHOOL**

In the VII semester, every candidate shall undergo practice school for a period of 150 hours evenly distributed throughout the semester. The student shall opt any one of the domains for practice school declared by the program committee from time to time.

At the end of the practice school, every student shall submit a printed report (in triplicate) on the practice school he/she attended (not more than 25 pages). Along with the exams of semester VII, the report submitted by the student, knowledge and skills acquired by the student through practice school shall be evaluated by the subject experts at college level and grade point shall be awarded.

**AWARD OF SESSIONAL MARKS AND MAINTENANCE OF RECORDS**

Two Sessional exams shall be conducted for each theory / practical course as per the schedule fixed by the college(s). The scheme of question paper for theory and practical Sessional examinations is given below. The average marks of two Sessional exams shall be computed for internal assessment as per the requirements given in tables – X.

Sessional exam shall be conducted for 30 marks for theory and shall be computed for 15 marks. Similarly Sessional exam for practical shall be conducted for 40 marks and shall be computed for 10 marks.

### **MINIMUM MARKS FOR PASSING EXAMINATION**

A student shall be eligible to carry forward all the courses of I, II and III semesters till the IV semester examinations. However, he/she shall not be eligible to attend the courses of V semester until all the courses of I and II semesters are successfully completed.

A student shall be eligible to carry forward all the courses of III, IV and V semesters till the VI semester examinations. However, he/she shall not be eligible to attend the courses of VII semester until all the courses of I, II, III and IV semesters are successfully completed.

A student shall be eligible to carry forward all the courses of V, VI and VII semesters till the VIII semester examinations. However, he/she shall not be eligible to get the course completion certificate until all the courses of I, II, III, IV, V and VI semesters are successfully completed.

A student shall be eligible to get his/her CGPA upon successful completion of the courses of I to VIII semesters within the stipulated time period as per the norms specified in 26.

**A lateral entry student shall be eligible to carry forward all the courses of III, IV and V semesters till the VI semester examinations. However, he/she shall not be eligible to attend the courses of VII semester until all the courses of III and IV semesters are successfully completed.**

**A lateral entry student shall be eligible to carry forward all the courses of V, VI and VII semesters till the VIII semester examinations. However, he/she shall not be eligible to get the course completion certificate until all the courses of III, IV, V and VI semesters are successfully completed.**

**A lateral entry student shall be eligible to get his/her CGPA upon successful completion of the courses of III to VIII semesters within the stipulated time period as per the norms specified in 26.**

**Any student who has given more than 4 chances for successful completion of I / III semester courses and more than 3 chances for successful completion of II / IV semester courses shall be permitted to attend V / VII semester classes ONLY during the subsequent academic year as the case may be. In simpler terms there shall NOT be any ODD BATCH for any semester.**

#### **INSTRUCTIONS TO THE CANDIDATES (EXAM HALL)**

**Students should adhere to schedule of examinations to be held in the course of the Academic year notified in the departments.**

- 1. Candidates should bring the Hall ticket for admission to the examination centre.**
- 2. The Hall ticket is issued as per the regulations and instructions issued by the University from time to time. If the candidate does not comply with the above requirements, the examination(s) taken by the candidate will be treated as cancelled.**
- 3. The candidates should appear in the centre prescribed by the University for their theory and practical examination.**
- 4. Any discrepancy with regard to the spelling of the name or the subject for which the candidates is permitted to the examination should immediately be brought to the notice of the Controller of Examinations of this University.**
- 5. Candidate should satisfy themselves, before answering that they have received the correct question paper.**

6. Candidates are instructed not to leave any pages blank in the Answer scripts. For Example, if the maximum number of pages allotted for a question in the question paper is 10 pages and the candidate completes the answer in 8 pages, the candidate should write the answer to the next question continuously without leaving any space or pages blank.
7. Candidate should be present at the respective centres for clinical, practical and oral examinations half an hour before the commencement of the examinations.
8. Answers must be written legibly in blue/black ink or ball point pen.
9. Candidates should write their Register No. in the specified column only in the Main Answer Book. Candidates are prohibited from writing their Register No. in any other place in the Main Answer Book.
10. (i). Writing Wrong Register No. in the Answer book will entail summary rejection of the Answer book. (ii). If candidate puts any special mark or writes anything will entail summary rejection of Answer book.
11. Candidates are prohibited from writing their names or any type or form of symbols at any place in the main answer book or additional answer sheets.
12. Separate answer books should be used for each section wherever it is specified. Answer written in the wrong answer book (i.e.) other than the one pertaining the section concerned shall not be valued.
13. Answer scripts of the candidates violating instructions (8), (9) and (10) shall not be valued.
14. The electronic devices such as calculators, Digital Diary, Mobile phone, pager or any other communication devices are strictly prohibited in the Examination Hall, possession of the said devices by the candidate shall entail cancellation of the examination for that candidate.
15. All the Text books, Notes and other informative materials should be left outside the examination hall.
16. Candidates are not permitted to enter the theory examination Hall with their aprons or over coats.
17. Candidates are permitted to enter the Practical/Clinical examination Hall with their aprons or over coats.
18. Candidates found guilty of using unfair means of any nature shall be liable for disciplinary action.

19. Candidates should produce the hall ticket on demand by the Invigilator/Chief Superintendent/Observer/Squad member.
20. Candidates will have to handover the Answer books to the Invigilator/Chief Superintendent before leaving the examination hall.
21. Candidates should be seated half-an-hour before the examination and strictly not allowed after that time.
22. The candidates shall not be permitted to leave the examination hall, before the expiry of sixty minutes from the commencement of the examination. Candidates allowed to leave the examination hall will not be allowed to re-enter the hall.
23. Candidates should ascertain the scheme for the practical and oral examinations in their respective Laboratories.

### **RAGGING MENACE AS PER UNIVERSITY GRANT COMMISSION (UGC)**

Ragging is a disturbing reality in the higher education system of our country. Despite the fact that over the years, ragging has claimed hundreds of innocent lives and has ruined the careers of thousands of bright students, the practice is still perceived by many as a way of ‘familiarization’ and an ‘initiation into the real world’ for young college-going students.

**The Ragging is defined as** any disorderly conduct, whether by words spoken or written or by an act, has the effect of teasing, treating, or handling with rudeness a fresher or a junior student. Indulging in a rowdy or undisciplined activity that causes or is likely to cause annoyance, hardship, or psychological harm or to raise fear or apprehension thereof in a **fresher or junior student**. Asking the students to do any act or perform something that such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or junior student. This can lead to adverse effects such as depression, anxiety, and sometimes even suicide.

### **Punishment Provisions**

Any student or group of students found guilty of ragging on campus or off campus shall be liable to one or more of the following punishments:

- Debarring from appearing in any sessional/ test/ university examination or withholding results

## *SCOP*

- Suspension from attending classes and academic privileges
- Withdrawing scholarships and other benefits
- Suspension from the college for a period of one month
- Cancellation of admission
- Debarring from representing the institution in any national or international meet, tournament, youth festival, etc
- Suspension/expulsion from the hostel
- Rustication from the institution for periods varying from 1 to 4 semesters or equivalent period
- Expulsion from the institution and consequent debarring from admission to any other institution
- Fine up to twenty five thousand rupees
- Imprisonment for a term which may extend to two years or with fine which may extend to ten thousand rupees or with both
- Collective punishment - When the students committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

Any institution that fails to take adequate steps to prevent ragging or fails to act in accordance with the Regulations or fails to punish perpetrators or incidents of ragging suitably is liable to the penalties and punishments as per the provisions of the Regulations.
